### **Capital Restructuring Financing Program**

Last week, the State announced that PPSs will be responsible for submitting capital needs requests on behalf of their partners, along with other requirements for funding. The [Capital Grant Requests Application](#) is **due February 20, 2015**. To ensure PPS partners have an opportunity to re-evaluate past submissions and submit new requests, the BLHC PPS will be releasing additional guidance and the submission process for capital asks to the PPS early next week.

### **COPA and ACO Application Documents Available**

The applications and FAQ for [COPA](#) and [ACO](#) are accessible for your review and completion by PPS Leads. Both sets of proposed [regulations](#) for these individual applications clarify how this process will be administered by the NYS Department of Health, Office of Regulatory Reform. Applications submitted on or before **December 22, 2014** will be notified of determination by **April 1, 2015**. If submitted after the deadline date, notifications will be made expeditiously after the determination date.
